Meet the three who help SMPA schedule work that works for you.

How often have you been about to start on a home project only to realize that you didn't have all the tools you need for the job? Sometimes it seems that the hardest part of getting something done, is just making sure you are ready to do it in the first place.

Now, imagine that your project was to repair and maintain 1,800 miles of electric power lines and electric distribution equipment over 3,600 sq. miles of some of the most rugged country in the United States. Where would you start?

Well, at SMPA, these repair and maintenance projects start with an Area Service Technician. These highly-trained and experienced employees are focused on the members and meeting their needs, as well as scheduling work for the crews and overseeing the flow of the jobs from start to completion. This includes, meeting with contractors, inspecting jobs, scheduling the work, and checking that materials are readily available, etc.

Because of our widely spread service territory and the variety of member needs across this territory, SMPA employs three individuals who leverage their local connections and area-specific knowledge to devise solutions that are smart, efficient, and that meet the specific needs of the job and the community that it affects.

Although the position of "Area Service Technician" is technically new, SMPA has always had someone meeting these scheduling challenges on behalf of the members. These positions differ in that they are not supervising others. "We are very excited to re-establish this sort of structure and implement new ideas in how we handle work flow to effectively carry out and meet the needs of our members." says SMPA Human Resources Manager, Carla Reams. "We consider our employees to be experts in this industry and have no doubt they'll bring their skills to the task."

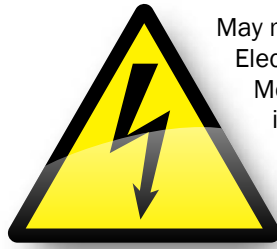


May is ELECTRICAL SAFETY MONTH
