You must receive electric service from San Miguel Power Association to qualify for rebates. Requests must be made within 180 days of purchase. Allow 8-12 weeks for rebate. Submission of application does not guarantee rebate. San Miguel Power Association reserves the right to inspect and verify appliance installation to process the rebate. All applications for 2017 rebates must be submitted by December 31st to be eligible for posted rates **All information must be included to process the application.**

## Premium Efficiency Special Purpose Motors

Applies to the installation of:

- Special purpose premium efficiency motors and all irrigation related motors
- Motors must be a minimum of 10 horsepower and a maximum of 500 hp.
- Motors must operate at a minimum of 15% load factor or for a minimum of 3 months each year. Motors less than 10 horsepower qualify if the aggregate for a single application.
- Pre inspection and post installation inspection by SMPA representative required

**\$9 per horsepower / \$1.50 per horsepower wiring assistance if motor replaces fossil fuel engine or is a new installation.**

## Variable Speed Drive Retrofit

Applies to the installation of:

- Variable frequency drives retrofit onto existing equipment such as irrigation wells or industrial machinery
  - New motors may be installed at the same time and may qualify for a separate motor rebate.
  - Replacement of existing VSDs for maintenance or other purposes does not qualify for an incentive.
- Pre inspection and post installation inspection by SMPA representative required

**The rebate shall be lesser of 50% of the cost of the VSD unit or calculated based on horsepower / minimum 25 horsepower VSD motor.**
