# BENEFICIAL ELECTRIFICATION

# WHAT IS BENEFICIAL ELECTRIFICATION?

**Beneficial Electrification** is the application of electricity to end-uses that would otherwise consume fossil fuels. Some examples would be traveling in an electric vehicle instead of a gasoline-burning one, heating your home with an electric heat pump rather than by burning natural gas; or replacing gas-engine powered tools like leaf blowers or weed whackers with electric versions.



Electrical applications are considered “beneficial” if they satisfy at least one of following conditions, without adversely affecting the others:

-  **They save consumers money.**
-  **They improve product quality, or consumer quality of life.**
-  **They reduce greenhouse gas (GHG) emissions.**
-  **They foster a more resilient electric grid.**

# BENEFICIAL ELECTRIFICATION REBATES:



## Electric Vehicles (EVs) and Charging Stations

- Up to \$250 - \$750 per EV depending on the type.
- Up to \$1000 per Level 2 Residential Charger
- Up to \$2000 per Level 2 Public Charger
- Up to \$6000 per Level 3 DC Fast Charger



## Green Medallion Home (All-Electric New Home Construction)

- \$750 per home.
- An additional \$250 for services signed up as “Totally Green” for 3 years.
- Individual rebates still apply. (Heat Pumps, Water Heaters, Appliances, etc.)



## Electric Heat Pumps

- Up to \$900/ton Air Source  $\leq 2$  tons  
\$450/ton Air Source  $> 2$  tons  
(\$20,000 rebate cap)
- \$1000/ton Ground Source, aka.  
“GeoThermal” [sic] (6 tons max.)



## Resiliency (Home Batteries)

- Up to \$500 for battery systems of 6kWh or larger (Does not apply to IC generators)



## Outdoor Power Tools (New)

- 25% up to \$150 per Lawn Mower (36 V min. or corded)
- 25% up to \$150 per Snow Blower (36 V min. or corded)
- 25% up to \$100 per Chainsaw (18 V min. or corded)
- 25% up to \$50 per Trimmer, Leaf Blower, or Power Washer (18 V min. or corded)



## E-bikes & Electric Motorcycles

- \$150 per bicycle/motorcycle (limit one per account)  
≥\$600 purchase price
- Intent is to replace commutes normally taken using fossil fuels.
