# WHAT IS BENEFICIAL ELECTRIFICATION?

**Beneficial Electrification** is the application of electricity to end-uses that would otherwise consume fossil fuels. Some examples would be traveling in an electric vehicle instead of a gasoline-burning one, heating your home with an electric heat pump rather than by burning natural gas; or replacing gas-engine powered tools like leaf blowers or weed whackers with electric versions.



Electrical applications are considered “beneficial” if they satisfy at least one of following conditions, without adversely affecting the others:

-  **They save consumers money.**
-  **They improve product quality, or consumer quality of life.**
-  **They reduce greenhouse gas (GHG) emissions.**
-  **They foster a more resilient electric grid.**

# BENEFICIAL ELECTRIFICATION REBATES:



## Electric Vehicle (EV) Charging Equipment

- Lvl 2: 50% match equip. & install \$500 max.
- Lvl 2 Public: 50% match of equipment and install \$1000 max.
- Level 3 DC Fast Chg: 50% match equip. inst.
  - 50-75 kW - \$3,000 max.
  - 76-149 kW - \$5,000 max.
  - >150 kW - \$7,500 max.



## Appliances & Recycling

- Refrigerator/Freezer Disposal-Only Rebate
  - Disposal only | 100% cost \$100 max.
- Clothes Dryer Rebate
  - Hybrid Heat Pump Dryer | \$180



## Electric Heat Pumps

(Air Source, Air-to-Water, Ground Source)

- Up to \$500/ton (1 - 5 tons)
- Up to \$250/ton (>5 tons)
- (\$20,000 rebate cap)



## Resiliency (Home Batteries)

- Up to \$750 for battery systems of 6kWh or larger
- (Does not apply to IC generators)
- (Programmed for Mon-Sat, 4-10PM)



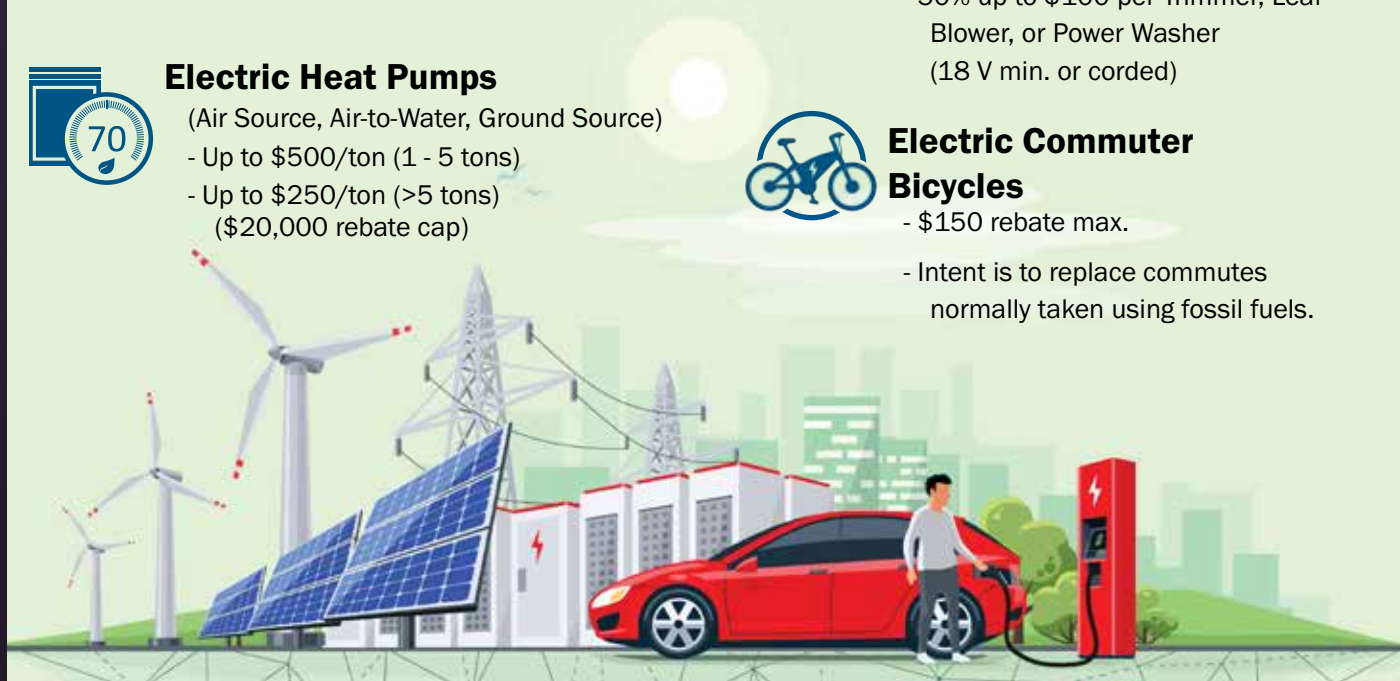
## Outdoor Power Tools (New)

- 50% up to \$500 per Lawn Mower (36 V min. or corded)
- 50% up to \$150 per Snow Blower (36 V min. or corded)
- 50% up to \$100 per Chainsaw (18 V min. or corded)
- 50% up to \$100 per Trimmer, Leaf Blower, or Power Washer (18 V min. or corded)



## Electric Commuter Bicycles

- \$150 rebate max.
- Intent is to replace commutes normally taken using fossil fuels.
