City of Ouray Goes Totally Green

At last month's City of Ouray Council Meeting, the City joined the Town of Ridgway and Ouray County in going Totally Green. By participating in the San Miguel Power Association (SMPA) Totally Green program, the City now consumes 100% renewably sourced electricity.

In many cases, renewable energy from the open market is used to fulfill Totally Green requirements. In the case of Ouray however, 100% of the city's municipal electricity use is covered by the output of the Ouray Hydroelectric Plant, which recently began producing electricity again after partnering with the Ouray Ice Park to make repairs following a six-ton rockfall event that damaged the facility's penstock in March of 2021. (See last month's story, "Cooperation Carries the Day") Given this unique situation, it is truthful to say that Ouray now generates its own power. (By the way, the statement also holds true for the County of Ouray, which is also a Totally Green participant for their municipal accounts).

The net proceeds from the City's contribution goes to the SMPA Green Fund. It is the Green Fund which enables SMPA to develop more locally sourced renewable energy projects. This fund is also the source

SMPA Member Dividends to Help Affordable Housing Efforts in Mountain Village

VILLAGE COURT APARTMENTS EYES ENERGY EFFICIENCY INVESTMENTS

It's been said that cooperative membership has its privileges, and one that was recently realized, was the distribution of over \$1 million in Member Dividends to long time members of SMPA. A point that is not always mentioned is the impact that these funds can have on local organizations that, in turn, help their communities.

One such organization is the Village Court Apartment (VCA) complex in Mountain Village. The scarcity of affordable housing in this area is no secret, but the Town of Mountain Village Housing Authority works to mitigate the problem by providing a 220 unit rental complex with 88 units subject to reduced rents in the 50-60% average median income range. In fact, all 220 units provide affordable rental rates to the community with similar rental rates extended to all units in the complex.

"We were thrilled!" said Michelle Haynes, Planning and Development Services Director and Housing Director for the Town of Mountain Village, when asked how the VCA responded to a Member Dividends check of over \$9,400 for dividends from its units. "We intend to apply the dividend towards replacing unit hot water heaters that have exceeded their lifespan with more efficient ones.

Nivol Wind Comes Online

NextEra Energy Resources, LLC and Tri-State Generation and Transmission Association celebrated the commissioning of the Niyol Wind Energy Center - with a dedication ceremony near Fleming, Colorado.

The project is the second of eight planned wind and solar projects to be constructed for Tri-State by 2024 under its Responsible Energy Plan.

The addition of Niyol Wind and the earlier Crossing Trails Wind project in 2021, brings the portion of carbon-free energy consumed by Tri-State's members, including SMPA, up to 40% of the total. With the addition of other renewable projects, this number is forecasted to rise to 50% clean energy by 2024.

Energy Efficiency upgrades can help low, moderate and middleincome individuals and families save even more on their monthly utility bills. Co-op member dividends help make these efforts possible. Haynes also mentioned other benefits of co-op membership: "We appreciate having representation, proactive rebate and incentive programs, and membership weigh in."

At SMPA, we applaud VCA's work to provide affordable housing and promote energy efficiency, and we're glad to help.
