Timing Matters

When you use electricity is as important as how much you use. Did you know that the power you use between 4 PM & 9 PM costs SMPA four times as much, and has a higher carbon impact than power used during the rest of the day?

Power bills are beginning to show information about the monthly usage "Peak," as well as the "On-Peak" and "Off-Peak" periods. If you shift your power use away from the peak period, you help lower SMPA's cost for everyone and lessen the strain on our electric grid.

Long-Term Affordability - Looking Ahead for our Members

Much has been said about the need for affordable housing in Colorado and beyond. Enter the nonprofit developer, Rural Homes, For Sale, For Locals (Rural Homes), with its bold notion to build and sell homes for under \$430K near markets in which average home prices can be in the millions. Through partnerships enabling low-cost capital, donated land, and a cost-efficient factory construction process, this seemingly impossible concept is becoming a reality.

"...but affordability applies to more than just the purchase price of a home," says Phil Zimmer, Member & Energy Services Supervisor of San Miguel Power Association (SMPA). One of the early home designs used an electric resistance heating solution in the cold winters of Western Colorado. "Those units may be cheap to buy, but they're expensive to run," says Zimmer. This highlights one of SMPA's core strategies. "We encourage not just electrification, but beneficial electrification." For example, within the model home, a ducted cold-climate air-source heat pump (CCASHP) could provide the same level of heat in the winter at about half of the monthly cost. As a bonus, the same unit also works as an air-conditioner during the summer months, during which outside temperatures can rise to 100 degrees.

If homeowners are on a limited income and their winter heating bill is still hundreds of dollars a month, it kind of defeats what we at Fading West are trying to do. The heat pumps will give heating and cooling and will be far more efficient.

The slightly higher upfront cost of the heat pump is paid over time through monthly utility savings. Again, with the motive of ongoing affordability, this total monthly cost is kept lower than that of inefficient, piecemeal climate control solutions.

"Now the model is being replicated in projects across the state and in other regions around the country," says Zimmer. "It's just because we were looking to make this project work for our members on a monthly basis." As affordable housing projects in Norwood, Ridgway, Ouray are being designed and constructed with the same long-term logic, SMPA would like to thank Rural Homes, San Miguel and Ouray counties, the Colorado Clean Energy Fund, and Fading West Construction, as well as the many other partners who have come together to overcome an absurd problem for the ultimate benefit of our communities and local families.
