The Power of Leveraging Generosity -The Naturita Park Success Story

It all began when local attorney and mother, Sara Bachman, watching kids play in a dilapidated Naturita playground, resolved "...we can do better!" On behalf of the Town, she applied for a Great Outdoors Colorado (GOCO) Parks and Recreation Master Plan Grant in 2018. That grant was awarded and it allowed the Town to hire Durango-based DHM Design to create a master plan for an outdoor recreation park that would prove to be a community asset for years to come. Having won a \$10,000 SMPA/CoBank Sharing Success Grant in 2018, the Town built a strong case for another GOCO construction grant of \$350,000 which they won in 2019.



"...and then the leveraging began!" stated Bachman. The town gathered other in-kind donations for various elements like decorative safety boulders, and dirt from an abandoned BMX track. As the project gathered steam, The Telluride Foundation kicked in \$50,000 to match Town funds. Additionally, the project managers applied for, and won, a grant to reduce the cost of playground equipment by \$92,000.

On behalf of the town, Bachman also applied to receive adventure course playground equipment through a KaBOOM!, Community-Built Playspace Grant. That grant was awarded, and the equipment was installed by community volunteers in October of 2021. Then the project grew to include the nearby San Miguel River with monies from the National Park Service Land Water Conservation fund and Colorado Water Conservation Board.

As impressive as this tale is, it is grounded by the original idea of young people and community-members just wanting a safe place to play outside. "One of the best memories

of this whole process was involving the grade school children to help design their playground," said Bachman. "They basically got to choose which play features they wanted."

Including all the in-kind donations, the total construction costs for the Naturita Town Park Improvements and Perimeter Trail came to \$919,162. Upon reporting this extraordinary feat, a smile floats across Bachman's face.



Board to Consider Raising Access Charge to Build Financial Stability and Cover Rising Costs

Volatility may characterize the global economy as well as the electric industry in recent times, but we feel it's best kept away from our members' power bills. That's why, for the past several years, San Miguel Power Association (SMPA) has been implementing a strategy of controlled, gradual increases to cover rising costs rather than directly passing through market prices to our members.

It's well-known that worldwide inflation has affected practically every economy, and the market for electrical equipment and tools has not been spared. Business expenses have risen and are likely to remain higher than prepandemic levels. Additionally, SMPA is anticipating a cost hike of over 6% for its wholesale power, which accounts for approximately 52% of the non-profit cooperative's overall expenses.

With these factors in mind, the SMPA staff is planning to propose a \$2 increase to its access charge. Currently, the single-phase access charge that most residential members pay each month stands at \$23.00 per month. If approved, the increase would bring the fixed charge, which is intended

to cover fixed costs of grid maintenance and system hardening, to a total of \$25.00 per month.

"This \$2 increase will not cover the projected increase in our wholesale power costs," says SMPA Chief Executive Officer, Brad Zaporski. "However, through tightening our belt and successful long term financial planning we will be able to cover our expenses while giving our members room to adjust to market conditions."

Several times over the past four years, the SMPA Board of Directors has taken advantage of opportunities to defer revenue. This practice, a ratestabilization tool, will make up for any losses SMPA may realize next year.

A temporary measure, the deferred revenue mechanism will help SMPA bridge a gap between the current rate environment and a yet-undefined future state. Currently, a number of rulings to affect the future relationship between SMPA and its current wholesale power provider, Tri-State Generation and Transmission (Tri-State) are under deliberation at the Federal Energy Regulatory Commission (FERC). "While questions remain about the future of



our power supply," stated Zaporski,
"one truth is becoming more and more
evident: the timing of electrical power
use will be one of our most powerful
money-saving tools as we move
forward."

To help draw member attention to this fact, SMPA has launched an information campaign called "Timing Matters." Part of the movement can be read on your power bill. The hours of 4 PM to 9 PM have been identified as the system "Peak." New line items, on the bill indicate "On-peak" and "Off-peak" power use, and members can now see when their account used the most energy within the billing period. This information, combined with the announced metric that "Onpeak" power costs the cooperative 4X as much as power used at other times, can help raise awareness of the challenge and of the opportunity that it presents.

Auto-Pay Draft Date Change
