Resolve to Save Energy and Money

AS THE NEW YEAR BEGINS, MANY OF US RESOLVE TO MAKE POSITIVE CHANGES—SAVE MONEY, LIVE HEALTHIER, OR SIMPLIFY OUR LIVES.

This year, consider a resolution that benefits both your household budget and the environment: saving energy at home. A few small adjustments can make a big difference, especially during winter.

One of the easiest steps is lowering your thermostat a few degrees. Even a slight reduction can noticeably cut heating costs while keeping your home comfortable. Wearing warm layers or using extra blankets can help bridge the gap.



- An effective strategy is sealing air leaks around windows and doors. Drafts let warm air escape and cold air enter, making your heating system work harder. Inexpensive caulk or weatherstripping is simple to apply and pays off quickly.
- Take advantage of natural warmth by opening window coverings during the day. Sunlight can help heat your home for free. Close curtains at night to trap that warmth indoors.
- If floors feel cold, adding area rugs can help insulate rooms and keep feet warmer.
- Try running appliances like the dishwasher, washing machine, and dryer outside peak hours of 4 PM to 9 PM to reduce energy demand and potentially lower costs.

New Rate Reminder

San Miguel Power Association, Inc. (SMPA) has increased its access charge by \$5 for most residential electric accounts, bringing it to \$33.00 per month. There has also been a 3¢ increase to the on-peak energy rate, bringing that rate to 25¢ per kilowatt-hour (kWh). These changes apply to energy used beginning December 15, 2025, and will first be reflected on members' January electric bills.
