Wind Damage Prompts SMPA to Take to the Air

EVEN IF YOU DON'T PAY PARTICULARLY CLOSE ATTENTION TO THE WEATHER, YOU STILL WOULD HAVE NOTICED THE WIND STORMS THAT HIT OUR REGION DURING THE THIRD WEEK OF LAST MONTH. WITH SUSTAINED WINDS OF UP TO 44 MILES PER HOUR, MOTHER NATURE GAVE OUR COMMUNITIES A SOUND REMINDER OF WHO'S BOSS.

Our electric grid received some of the worst of this fury as trees and vegetation slammed into power poles and power lines throughout our service territory. Power outages ranged in size from just a few meters affected to over 400. Through it all, our line crews responded quickly and with determination. A quick gander at SMPA's facebook page will reveal how much appreciation these brave professionals receive from community members. Thanks to all for your patience and support as SMPA battled to keep the lights on in some of the most rugged country under some of the harshest conditions.

Even after the winds subsided, our crews still had plenty to do and, in some of the more difficult locations, it was nice to get a little help. Camp Bird is one of those locations. In this area, a total of nine trees were blown into the power lines. Four power poles were knocked down and three of these were on a rock shelf at an elevation of over 11,000 feet. To bring new power poles to locations like this, SMPA is glad to be able to rely on commercial helicopter companies like familyowned Mountain Blade Runner out of Montrose.

The work is spectacular to observe. After a planning and safety briefing with the work crews, the pilot lifts off and hovers as his assistant attaches the pole to a rope that is suspended from the helicopter. Once the assistant is clear of the area, the helicopter hoists the pole up and carries it high into the air. He flies it to its destination, and with crew guidance via radio and hand signals, he gently lowers it into a hole that is less than two feet in diameter. With the pole detached, the pilot returns to the staging area to get another pole. In about 30 minutes, all four are in place, and line crews begin the arduous task of straightening and setting the poles, and re-mounting the lines.

We had almost all of our crew members on site to help with the re-build and I think it's worth noting that not one person complained or said a discouraging word about it. They simply asked where to be and when.

We're so grateful to SMPA and Basin for their support," said Greenwood. The Fun Run is scheduled for May 2 at the Elementary School.


