A Real Life-Saver... SMPA Donates AED Defibrillator to Ridgway Secondary School

"The ability of these devices to save lives is amazing," said Ridgway Schools Superintendent, Susan Lacy about the Automated External Defibrillator (AED).

The AED is used to help those experiencing sudden cardiac arrest. It's a sophisticated, yet easy-to-use, medical device that can analyze the heart's rhythm and, if necessary, deliver an electrical shock, or defibrillation, to help the heart re-establish an effective rhythm. According to the Red Cross, the national average response time for first responders once 9-1-1 is called is 8-12 minutes, and for each minute defibrillation is delayed, the odds of survival are reduced by approximately 10%. Because of this, more and more organizations are putting AEDs in their common rooms and hallways.

Ridgway Secondary School is one such organization. School Principal, Jeremy Voytko explained, "We have one AED on campus, but adding another will double our options for emergency access."

Amazing as it is, the AED is not cheap. Fortunately, the school staff was aware of SMPA's practice of community support through corporate donations. The school applied, and the Board approved a donation, including



matching funds from cooperative partner, Basin Electric to cover the full cost of another AED for the school. "The new AED will be located in the intersection of the classroom hallways, the admin offices and the soccer fields," says Voytko.

Tri-State Announces 104 MW Crossing Trails Wind Farm



Last month, SMPA's wholesale power provider, Tri-State Generation and Transmission, (Tri-State) announced plans to invest in the building of its fifth wind-energy project, called the "Crossing Trails Wind Farm." The 104 megaWatt (MW) system will be located near the town of Seibert, Colorado and will provide enough emissions-free energy to power more than 47,000 average rural homes.

The announcement follows Tri-State's January announcement that it would be investing in the 100 MW solar array, called "Spanish Peaks Solar" near Trinidad, Colorado. The combination of these renewable energy projects will contribute to the quickly-growing emissions-free portion of Tri-State's energy mix.

A wind turbine at Tri-State's Carousel Wind Farm is constructed in the service territory of KC Electric which will also host the Crossing Trails wind farm.

West End Reliability Work Continues: Line Upgrades Ahead

SMPA Engineers are constantly looking for ways to improve service reliability. That means not only preventing outages, but also providing options for re-routing power during outages that inevitably occur in our rugged service territory. One prime opportunity for this kind of grid improvement exists between our substation in Nucla and the one in Norwood.

SMPA Service Planning Supervisor, Jeremy Fox explains, "With a higher-capacity line between them, these two substations could serve as backup for each other. This could greatly reduce the amount of outage time members would experience in case of a substation failure." With this long-term goal in mind, SMPA planned a three-stage project to upgrade the connection.

Stage 1, which upgraded the conductor from Norwood to Redvale was completed in 2013. The next stage of upgrades, projected to start in the summer of this year, connects to Nucla and will run from West Naturita and East along the river valley. It will be made ready to connect to a central stage, which is in the permitting process and will be planned for some time between 2022 & 2025.
