Telluride's Own Solar Garden Awakens

JUST OUTSIDE OF TELLURIDE, NESTLED INTO THE DEEP CREEK MESA, ABOVE THE AIRPORT, A SILENT MIRACLE IS TAKING PLACE. USABLE ELECTRICITY IS BEING GENERATED FROM PURE SUNLIGHT AND TRANSMITTED ONTO THE LOCAL POWER GRID. "THERE'S CARBON-FREE POWER BEING PUT ON THE GRID ... AND THAT'S A GOOD THING," SAYS TIM ERDMAN, OWNER AND OPERATOR OF THE NEWLY COMMISSIONED LAST DOLLAR COMMUNITY SOLAR GARDEN.

This 250-kilowatt (kW) facility is the third community solar array to be tied to the San Miguel Power distribution grid, following arrays in Paradox and Norwood. As with its predecessors, Last Dollar Solar subscriptions are available for any SMPA member who would like to include solar generation in their carbon footprint calculation, but subscriptions may be particularly attractive to Telluride and Mountain Village residents who are currently subject to Telluride Energy Mitigation Program (TEMP) or Renewable Energy Mitigation Program (REMP) regulations. Under these regulations, the array qualifies as offsite renewable mitigation and, for many, subscriptions can cost less than the associated fees.

As is the case with other arrays on SMPA's grid, subscribers will see a credit on their power bill equal to their portion (up to 25 kW) of the array's energy production each month. SMPA is able to purchase energy from the array due to a 5% carve-out of an all-power-requirements contract with electric wholesaler, Tri-State Generation and Transmission (Tri-State). "This addition brings us right to the edge of what we are allowed to locally generate under the current contract," says SMPA Energy Services Executive, Terry Schuyler. "However, in

response to calls from our membership for more local, renewable energy, we have been pushing Tri-State to allow more flexibility in the contract."

SMPA's efforts seem to have been rewarded.... As the recently announced Tri-State Responsible Energy Plan will allow SMPA to add another 2% (appx. 2000 kW) of community solar gardens in the near future. SMPA hopes to capitalize on this with plans being made to begin more solar development this year.

For now, members who find rooftop solar to be impractical, have another option. They can purchase a subscription to Erdman's Last Dollar Community Solar Garden in Telluride. Erdman himself, sees the array as just a beginning. "My dream and my expectation is that, as solar photovoltaic equipment improves, it will become part of the built environment. I'd like to see how much I can help in terms of showing people what can be done and helping them get it done."

Mid-May, 2020:


Ballots mailed to members in Districts #1 & #4.
