- Unplug outdoor tools and appliances when not in use.
- Avoid damp conditions—including wet grass—when using electricity.

A Sweet Surprise Sharing Success Grant helps Apple Core Project Grow

Have you ever bitten into a luscious-looking apple only to be disappointed by its lack of sweetness and flavor? According to Jen Nelson, landscaper, master gardener, and co-founder of the Apple Core Project of Western Colorado, “Modern apples, like the red delicious apple, have been modified specifically for their appearance, so the flavor wanes over the years.” So-called “heirloom apples,” however, like those found on Wright’s Mesa and in the West End, have not been genetically modified. “At high elevations, part of what makes any Colorado apple special is that they sweeten up,” says Nelson “and the increased ultra violet light causes the nutrient content to nearly double.”

The Apple Core Project was founded in 2015 by Nelson and her friend, former professional marketer and business manager, Melanie Eggers. With an educational certificate in Holistic Nutrition and Culinary Studies from the Bauman College, she now helps local food businesses with various marketing endeavors. Apple Core’s goal, according to Eggers, is to use the age-old technique of grafting to preserve and propagate heirloom varieties.

In the old days, apple trees were planted some 25 feet apart in rows, but Eggers said that Apple Core Project is using a “food-forest model,” where strawberries, garlic, mulberries and other plants co-exist around each tree in the orchard. Some of these plants are edible or medicinal while

other companion plants attract pollinators and help the apple trees thrive. The new growing model will be only one of the advanced methods on display at the Community Demonstration Orchard planned to be installed at the Piñon Farm Homestead in Nucla. “This project supports local economic development and business, while also preserving the unique history and landscape of the region,” says Eggers.

This year, San Miguel Power Association (SMPA), and cooperative partners, CoBank and electric power wholesaler, Basin Electric were proud to award a “Sharing Success” grant to the Apple Core

Project to help build the demonstration orchard. “We give the Sharing Success Grant to financially support projects that work to expand entrepreneurial opportunities and bring revenue to our towns and counties,”

said grant administrator, and SMPA Key Accounts Executive, Paul Hora. Cooperatives like SMPA, CoBank and Basin Electric have a fundamental drive to support their communities and the Sharing Success Grant is a perfect expression of that care.



With funding from three cooperative sources, the grant has become known as a powerful tool for community initiatives. From an economic development perspective, The Apple Core project practically overflows with opportunity.

The term “heirloom” refers to varieties of fruit that were originally planted many generations ago, and have survived without human interference ever since. Near the turn of the 20th century, the areas surrounding Norwood, Nucla, Naturita and Paradox abounded with fruit orchards planted by visionary farmers like U.H. Walker, nursery manager at the Piñon Farm Homestead, Edwin Payson, Ph.D., a world-renowned botanist, and P.T. Stevens, producer of fruit widely-noted for its quality. (A 1906 article reported an apple delivered to Telluride from the Stevens ranch measuring 15 inches in circumference and weighing 18 ounces.)
