Defiance and Determination Wrought in Ice

“When the crampons and tools become extensions of my body, the movement feels natural, fluid, rhythmic, and the surrounding cold air and quiet beauty make me feel relaxed and alive.”

For the uninitiated, the words of Mountaineering Guide, and seasoned ice climber, Andrea Charest may help explain the strange obsession that has given rise to one of the most daring sports of modern culture, ice climbing.

Even those locals who prefer to celebrate life on solid ground will have to admit that the sport has brought, not only excitement, but increasing economic benefit to the mountain town of Ouray during winter seasons over the past few decades. “Starting every November, using overflow water from the City of Ouray and more than 250 sprinklers and showerheads, Ice Farmers spray water down the canyon walls of the Uncompahgre Gorge to form awe-inspiring walls of ice,” reports Peter O’Neil, Executive Director for the Ouray Ice Park.

“But the Ouray Ice Park needs more water than it gets to realize its full potential,” says O’Neil. With this in mind, he and the small non-profit team that manages the Ice Park began the formidable task of raising funds to secure another permanent water supply line from the nearby Weehawken Creek. In 2019, The Ice Park won a \$6000 Sharing Success Grant from San Miguel Power Association to support the cause.

“The COVID-19 health crisis has added another very unpredictable variable in the Ice Park’s operations,” says O’Neil. Even though Ice Park management is planning for the best-case scenario, their commitment to safety demands that they invest in additional training and staff to help protect visitors. Still, O’Neil is optimistic. “Ouray’s unique mountain location along with ice climbing being socially distant in nature makes us hopeful we will be able to host a safe ice climbing season beginning in December.”

Handling the extra demands of a season impacted by COVID-19, hasn’t kept the organization from moving forward with a feasibility study for the water diversion project. “The Ouray winter economy is depending on us,” says O’Neil. Perhaps the determination of this organization shouldn’t be surprising, given the nature of the sport that it promotes. “None of the other daily problems or tasks matter when you’re on the wall,” says Charest. “...the mental side of climbing has to take over—the reassurance that your body can do this. Breathing. Facing fears and working through them, knowing that you’ve mitigated as much risk as possible...it’s a powerful feeling.”

The last strategic planning session was in 2017, and regular updates are scheduled every three years. Working with a consultant, the board reviewed the cooperative’s strategic direction in these fields:



RELIABILITY & RESILIENCY

Strategic Objective: Identify and prioritize reliability and resiliency risks and issues. Initial focus shall be on a fire mitigation.



FINANCIAL/POWER SUPPLY/RATES

Strategic Objective: Determine the optimal long-term power supply strategy that best achieves safe, reliable, cost effective, and environmentally responsible service to our members.



SAFETY/CULTURE/PEOPLE

Strategic Objective: Continue to improve SMPA’s overall safety and work culture.



TECHNOLOGY

Strategic Objective: Fully optimize all technology.



COVID19 & CRISIS MANAGEMENT

Strategic Objective: Further develop Crisis Management Plan in order to best respond to external threats or crisis.


You Can Now Receive Outage Notifications Via Text or Email – Here’s How:
